**Sumitrans Completes Acquisition of ServiceCraft Logistics
from May Logistics Services**

New York and Chicago – September 28, 2004—The completion of the purchase of ServiceCraft Logistics (ServiceCraft) by Sumitrans Corporation (Sumitrans) from May Logistics (MLS) was jointly announced by the companies today. Sumitrans is a wholly-owned subsidiary of Sumitomo Corporation of America (SCOA). MLS is a portfolio company of Chicago based private equity firm Code Hennessy & Simmons LLC. Price and terms were not disclosed.

“Earlier this year, MLS, with investment bankers Lazard and Republic Partners, set out to find a buyer that would value and expand ServiceCraft’s capabilities and geographies to meet the evolving global needs of its customers. The strength of the Sumitomo name will substantially grow this business and integrate its product and service offerings with our own international capabilities.”

“ServiceCraft has a great reputation for going the extra mile to take care of their customers,” said Michael Muhich, Senior Vice President of Sumitrans. “The work ethic of the personnel, their dedication to serving customers, and the strong value system engrained in the company culture makes ServiceCraft highly attractive to Sumitrans.
