#### Scope

- Maintain inventory accuracy through timely processing of inventory transactions. Responsible
  for the physical accuracy of inventory records as held in iTIMS (physical count must match iTIMS
  stock records at all times).
- Supervision of OCTG material movement operations across projects including:
  - Purchase Order material receiving.
  - Rig preparation of OCTG items and coordination of outbound shipments.
  - Rig return processing.
  - o Optimisation of Aberdeen inventory levels.
  - Miscellaneous material movements processing.
  - Project process improvement initiatives.
- Interface with third party contractors to ensure satisfactory contractual performance.
- Attend internal and external planning meetings as required to perform job responsibilities.
- Represent the company at customer "rig calls" and provide delivery progress information.
- Prepare and submit required management reports.
- Performance reporting against agreed yard KPI's.
- To take part in scheduled training courses and on the job training in the ongoing pursuit of personal and professional development.
