## Notice Regarding Partial Amendments to Articles of Incorporation

Sumitomo Corporation (the "Company") hereby announces that it has resolved at its meeting of the Board of Directors held today to submit a proposition for partial amendment of its Articles of Incorporation to the 150th Ordinary General Meeting of Shareholders to be held in June 22, 2018, as detailed below.

## 1. Purpose of Amendments to Articles of Incorporation

- (1) The location of the Company's head office as set forth in Article 2 (Location of Head Office) of the current Articles of Incorporation shall be changed from Chuo-ku, Tokyo, to Chiyoda-ku, Tokyo, to coincide with the relocation of the head office. This change shall become effective as of the date of such relocation, which will be determined at a Board of Directors meeting to be held before the 151st Ordinary General Meeting of Shareholders to be held in 2019, and a Supplementary Provision will be added to clarify the said effect. The Supplementary Provision shall be deleted after the effective date of the relocation of the head office.
- (2) Changes shall be made in the business purposes stipulated in Article 3 (Purposes) of the current Articles of Incorporation in order to define the Company's business purposes in alignment with the current status of the Company's business.
