The space can be modified from a casual meeting for two at lunchtime to a super-sized catered corporate event. The floor-to-ceiling glass walls provide a seamless transition of indoor and outdoor spaces. Miami Tower's new Sky Lounge, together with the existing Sky Lobby and the 17,500 SF outdoor Sky Terrace, creates an extraordinary new stage for events in downtown Miami.
