The American Red Cross and their partners continue to work tirelessly to get disaster assistance to wildfire survivors as quickly as possible. Together, the Red Cross and the county government have provided more than 39,000 overnight emergency shelter and hotel stays on Maui and Oahu. They are coordinating with the Hawaii Emergency Management Agency and FEMA to care for displaced residents in hotels. Since the fires began, more than 670 trained Red Cross disaster workers have deployed to Hawaii or helped virtually, and have provided over 213,000 meals and snacks to people in need.
