

Privacy Policy of Saikai Offshore Wind Farm Project  
(Basic policy regarding the handling of personal information)

Sumitomo Corporation (hereinafter referred to as "the Company") will handle personal information appropriately in accordance with its Privacy Policy with regard to the protection of personal information handled by the Company in connection with Saikai Offshore Wind Farm Project in Saikai City, Nagasaki Prefecture (hereinafter referred to as "the Project"), as set forth below. Furthermore, the meanings of the terms used in this document shall be as set forth in the "Act on the Protection of Personal Information" (Act No. 57 of 2003, including subsequent amendments, hereinafter referred to as the "Personal Information Protection Act").

**I. Items of personal information to be acquired**

In carrying out this business, we will collect the following personal information:

- (1) Information regarding the business site, routes for transporting business materials and equipment, and residents living near these candidate sites  
Contact information such as name, address, telephone number, and email address, as well as information about your health at the time of attending the Company's briefing session
- (2) Information regarding the landowners of the business site, routes for transporting business equipment and materials, and potential sites for such sites  
Name, address, telephone number, email address and other contact information, family register and land registry information, information about family and kinship structure, and information about your health at the time of attending the information session held by our company
- (3) Information on those who attended the information sessions related to this project and those who provided us with opinions regarding this project  
Contact information such as name, address, telephone number, and email address, as well as information about your health at the time of attending the Company's briefing session
- (4) Information on crew members who will be on board vessels arranged by our company or its contractors for the purpose of marine surveys and other activities related to this project  
Contact information such as name, address, telephone number and email address, and information listed in your family register

- (5) Information regarding business partners (including contractors, consultants and advisors) related to this business

Company name, affiliation, position, name, address, telephone number, email address, and other contact information

## **II. Purpose of Use of Personal Information**

We will use personal information acquired through this business for the following purposes. In addition, if the Company notifies or publicly announces the purpose of use of personal information separately from this policy, such content shall take precedence.

- (1) To understand the rights and interests of the business site for this project, the routes for transporting business equipment and materials, and potential sites for these, and to make the necessary contact, negotiations, or procedures to acquire them or use them as business site or routes for transporting business equipment and materials, etc.
- (2) To provide necessary explanations regarding this project to local residents and landowners regarding the project site, routes for transporting project equipment and materials, and potential sites for these.
- (3) To understand the opinions and intentions of residents and landowners in the vicinity of the business site, the route for transporting business materials and equipment, and potential sites for these, those who attended explanatory meetings related to this project, those who provided opinions on the Environmental Impact Statement, and those who made other inquiries about this project, and to use this information as a reference for moving forward with this project.
- (4) In relation to this project, apply for licenses and permits and other administrative procedures with national or local governments or similar organizations, and carry out reports and other procedures.
- (5) To contact, negotiate, and take necessary procedures with companies doing business with us.
- (6) For any other necessary communication, negotiations or procedures in order to promote this project.

### **III. Joint Use**

We will carry out this business as a joint venture with our partner companies. For this reason, the personal data described in "I. Items of personal information acquired" above will be used jointly with partner companies and joint venture companies formed between partner companies (for details, see Mirai Enoshima - Offshore wind power generating plants that will play to the future of Enoshima | Saikai City, Nagasaki Prefecture) for the purposes described in "II. Purpose of use of personal information." Our company (Otemachi Place East Tower, 2-3-2 Otemachi, Chiyoda-ku, Tokyo / Representative Director, President and CEO, Ueno Shingo) is responsible for managing personal data.

### **IV. Safety Control Measures**

We take the following safety control measures for personal data we hold:

(1) Safety control measures within our company

As a measure to prevent the leakage, loss, or damage of personal information, the Company has established and established internal regulations, etc., and has taken necessary and appropriate measures for the safe management of personal information, such as appointing a personal information manager, having employees attend regular training, taking measures to prevent theft and loss of devices that handle personal information, and implementing access control.

(2) Supervision of employees

When our company has employees engaged in this business handle personal information, we will impose confidentiality obligations on such employees and provide necessary and appropriate supervision, such as by conducting regular inspections of the handling status, in order to ensure the safe management of such personal information. Furthermore, when the Company outsources all or part of the handling of personal information to an external party, the Company will enter into appropriate contracts, check the status of their implementation, and otherwise provide necessary and appropriate supervision to ensure the safe management of the entrusted personal information.

### **V. Provision of personal information to third parties**

We may provide personal information to the extent necessary to carry out applications, reports, and other procedures related to applications for licenses and permits, etc. and other administrative procedures described in "II. Items of personal information to be collected" (4) above, to the national

or local government entity that has jurisdiction over such procedures. Furthermore, except as otherwise specified in this Policy or permitted by law, we will not provide personal information to third parties without the prior consent of the customer.

## **VI. Inquiries etc.**

Inquiries regarding our handling of personal information and safety control measures, procedures for requesting disclosure or correction of personal data held by us, and complaints will be accepted via the following methods.

(1) Reception procedure

We will provide you with details about the application procedure when you make your request, but depending on the content, we may ask you to submit an application form specified by our company.

i. If you are the person in question

Driver's license, health insurance card, passport, or other official document

ii. In case of a representative

In addition to identity documents, a power of attorney
